2. An Expert Team conducted onsite data verification of the programs on 23rd September, 2022. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted accreditation for further 3 years. **Government Womens Polytechnic College, Shivaji Nagar, Bhopal-462016, Madhya Pradesh** should submit fresh online application through eNBA portal in new SAR January, 2019 document at least five months before the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Government Womens Polytechnic College, Shivaji Nagar, Bhopal-462016, Madhya Pradesh** as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.
