1. The Governor agrees to pay to the candidate during the course of training at the
said institution monthly scholarship of Rs. _____
(Rupees _____ only). The right to revise decision in
regard to payment, of the amount of scholarship shall be final and binding on the
candidate.
2. The candidate here by agrees that he shall delight completes the prescribed
courses of training at the said institution and shall abide by the rules from the time
being in force regulating the conduct of student at the said institution.
3. On completion of the course of training at the said institution and passing the final
examination, the candidate shall if required by the governor within six months of
the completion of the training serve the Government of Madhya Pradesh for a
period of not less than five year in the Madhya Pradesh Government Service from
the date of assuming charge of his duties shall rejoin his former post within a
period of fifteen days and shall continue to serve the state Government in the post
or in any other equivalent post offered to him by the Governor.
4. While in service in accordance with clause (3) above the candidate shall faithfully
diligently and with skill ability perform his duties and observe the rules for the
time being and/in force made by the Government of Madhya Pradesh for the
conduct of their servants.
5. During the period for training at the said institution the candidate shall not seek,
apply for or accept private job or service in either department of Government
either Central or State without the previous sanction in writing of the Governor.
